WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the White Mountain Apache Tribe by Resolution No. 61-67 adopted June 28, 1961 approved Mrs. Genevieve B. Truax as deputy tribal treasurer to act during the temporary absence of Mr. Paul Simmons, Tribal Treasurer, and


WHEREAS, by the same resolution Mrs. Mary C. Endfield, Tribal Secretary, was appointed as alternate co-signor to act during the temporary absence of Mr. Lester Oliver, Tribal Chairman, and

WHEREAS, these individuals were directed to secure bond in the amount of \$75,000 and \$10,000 respectively.

BE IT RESOLVED that bond No. B-127410 in the amount of \$75,000 and bond No. B-127411 in the amount of \$10,000 having been obtained by Mrs. Genevieve B. Truax and Mrs. Mary C. Endfield, co-signor, with the Standard Accident Insurance Company, Detroit, Michigan and that said bonds are hereby approved by the White Mountain Apache Tribe.

The foregoing resolution was on August 3, 1961 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) and (i) of the Amended Constitution and Article I, Section 4 (a), (b), (c) and (d) of the Amended By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).



Resolution No. 61-76 was adopted by the White Mountain Apache Tribe on August 3, 1961 pursuant to authority vested in it by Article V, Section 1 (a) and (i) of the Amended Constitution and Article I, Section 4 (a), (b), (c) and (d) of the Amended By-Laws of the Tribe.

This Resolution approves Bond No. B-127410 in the amount of \$75,000 covering Mrs. Genevieve B. Truax, Deputy Tribal Treasurer and Bond No. B-127411 in the amount of \$10,000 covering Mrs. Mary C. Endfield as alternate co-signor for Mr. Lester Oliver.

Under the authorities quoted this Resolution is not subject to rescission. The bonds, however, are subject to approval of the Area Director and are being transmitted by separate communication.
