## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribe is an unchartered organization operating under the Indian Re-organization Act of June 18, 1934 (48 Stat. 984) as amended by the Act of June 15, 1935 (49 Stat. 378) and operating under the provisions of the Amended Constitution and By-Laws of the White Mountain Apache Tribe approved by the Secretary of the Interior May 29, 1958 and adopted by the White Mountain Apache Tribal voters June 27, 1958, and
- WHEREAS, a letter of February 27, 1963 from the Assistant Area Director asked for a clarification of the Credit needs of the Tribe from the Revolving Credit Fund, and
- WHEREAS, it is necessary to modify the list of priorities as established by the White Mountain Apache Tribal Council in connection with a loan application for \$4,000,000.00 dated May 24, 1961, and
- WHEREAS, such changes will increase the overall benefits to the social and economic welfare of the Tribe and its members.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that this list of priorities supercede the list dated May 24, 1961 and the list is hereby changed as follows:
