


RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, Evans Quintero on January 31, 1966, signed a document entitled "Agreement For Voluntary Liquidation of Loan" for house and improvements on the following described land: Located in the East Fork-Seven Mile Community in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 29; T5N; R22E, a rectangular plot 208.7 feet east and west by 208.7 feet north and south and further described as follows: Beginning at the R.E.A. power pole directly across from the East Fork Trading Post, and counting it as #1, travel down the road in a westerly direction to pole #2; thence 816.0 feet in a northerly direction to the SE corner of the above plot, and
- WHEREAS, Ryan and Minnie Quintero have applied for a loan through the Revolving Credit Loan Program to purchase the property on the above described land, and
- WHEREAS, a homesite lease is required for housing loans by Section 23 (e) II of the Declaration of Policies and Plan of Operation approved September 18, 1963, and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection to the use of the land by Ryan and Minnie Quintero.
- BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe does hereby approve and grant a homesite lease to Ryand and Minnie Quintero for a period of twenty-five (25) years at the rate of \$12.00 per year payable annually in advance on the first day of the month following the effective date of the lease with annual payments of like amount on the same date each year thereafter in accordance with the terms of the lease for so long as the lease is in effect.
- BE IT FURTHER RESOLVED that the Tribal Chairman shall execute said lease for and on behalf of the White Mountain Apache Tribe in accordance with Tribal Ordinance No. 44; the effective date of the commencement of said lease being the date of the approval of the loan by the Secretary of the Interior or his designated representative.
- BE IT FURTHER RESOLVED that this lease to Ryan and Minnie Quintero shall automatically cancel any prior lease or assignment on the above described land subject to the following:
- BE IT FURTHER RESOLVED that should the loan not be approved within ninety (90) days from the date hereof, the lease to Ryan and Minnie Quintero shall thereby automatically terminate.

The foregoing resolution was on June 2, 1966 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (b) and (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
