




RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, Ronnie Lupe is no longer a member of the White Mountain Apache Tribal Council and is presently authorized to sign checks drawn upon the disbursing and payroll accounts of the White Mountain Apache Tribe on deposit with the First National Bank of Arizona, Pinetop, Arizona, and McNary, Arizona, and
- WHEREAS, it is the desire of the Council that his authority to sign checks be withdrawn and others substituted.
- BE IT RESOLVED that the authority previously granted to Ronnie Lupe to sign tribal checks be hereby revoked and that authority to sign tribal checks be delegated to Fred Banashley, Sr. and West Anderson.
- BE IT FURTHER RESOLVED that Mary Endfield, Malye Malone, Ivan Kitcheyan and Delta Brewer be retained as authorized signers of tribal checks.
- BE IT FURTHER RESOLVED that the First National Bank of Arizona, as a designated depository of the White Mountain Apache Tribe, and it is hereby requested, authorized, and directed to honor checks, drafts or other orders for the payment of money drawn in the White Mountain Apache Tribe's name, including those drawn to the individual order of those persons whose names appear thereon as signer or signers thereof, when bearing or purporting to bear the facsimile signatures of any of the following:

- and the First National Bank of Arizona shall be entitled to honor and to charge the White Mountain Apache Tribe for all such checks, drafts or other orders, regardless of by whom or by what means the facsimile signature or signatures thereon may have been affixed thereto, if such facsimile signature or signatures resemble the facsimile specimens duly certified to or filed with the First National Bank of Arizona by the Secretary of the White Mountain Apache Tribe.
- BE IT FURTHER RESOLVED that this resolution shall remain in full force and effect until written notice of the revocation thereof shall have been delivered to and received by said bank.
- BE IT FURTHER RESOLVED that the facsimile signatures previously furnished to the First National Bank of Arizona and authorized in Tribal Resolution No. 66-66 be honored by the First National Bank of Arizona when appearing on tribal checks drawn against the tribal payroll account through 15th May, 1970.

The foregoing resolution was on May 7, 1970 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (b) and (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
