BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that \$69,776.94 be approved and advanced to the Sunrise Enterprise for the opening budget of the Motel.

The foregoing resolution was on August 7, 1972 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1953 and approved by the Secretary of the Interior on May 29, 1953, pursuant to Section 16 of the /ct of June 18, 1934 (48 Stat. 984).
