## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has directed the Finance Committee to prepare a reduced operating budget for 1972-73, and
- WHEREAS, the Finance Committee submitted to the Council their recommendations on operating budget cut of \$204,070.20, and
- WHEREAS, the Tribal Council accepts these recommendations, and
- WHEREAS, submitted with this resolution is the attached budget modification reflecting the item by item reduction in the budget.
- BE IT RESOLVED by the White Mountain Apache Tribe that the operating budget for 1972-73 be reduced in the amount of \$204,070.20 and resubmitted to the Superintendent and the Area Director for approval.
- BE IT FURTHER RESOLVED that since the operating year for the Tribe began May 1, 1972, that every effort be made for expediting the approval of the Tribal Budget as soon as possible.

The foregoing resolution was on August 28, 1972 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
