BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the budget for the general operating expense in the amount of \$476,594.00 is hereby approved for the operation of the Sunrise Motel for Fiscal Year May 1, 1972 and ending April 30, 1973.

The foregoing resolution was on September 18, 1972 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
