

Resolution No. 74-10



Fort Apache Indian Agency White River, Ariz

- WHEREAS, the White Mountain Apache Tribe has brought an action in U. S. District Court for the District of Arizona, seeking a determination of the State of Arizona's Power to (impose) use fuel and motor carrier taxes on logging companies contracting with the Fort Apache Timber Company, and
- WHEREAS, all the logging operations are conducted entirely on the Fort Apache Indian Reservation on roads built by the Tribe, the Bureau of Indian Affairs, and a minimum amount on dedicated State Highways, and
- WHEREAS, the direct burden of these taxes will be passed on to the Tribe through higher contract prices, and
- WHEREAS, the State of Arizona makes no contribution to the building or maintenance of the Bureau of Indian Affairs and Tribal Roads, and
- WHEREAS, the attempt to tax the contractors carrying on their business solely within the boundaries of the Fort Apache Indian Reservation is a direct interference in the Tribe's power to be self-governing and be the regulator of logging activities, and furthermore burdens the main source of Tribal income, and
- WHEREAS, the Tribal Council believes that the Solicitor General and/or the U. S. Attorney on behalf of the United States could aid the Tribe's position by filing an Amicus Curie Brief.
- BE IT RESOLVED that the U. S. Solicitor General of the Bureau of Indian Affairs Office and the United States Attorney on behalf of the United States be requested to join as a friend of the Court and file an Amicus Curie Brief for the benefit of the White Mountain Apache Tribe in White Mountain Apache Tribe, et al, vs. Jack Williams, et. al., No. CIV 73-788 PCT WEC presently pending in the U. S. District Court for the State of Arizona; in which, the State of Arizona is attempting to assess use fuel and motor carrier taxes on the contractors working for the Fort Apache Timber Company where all logging activities take place within the bounds of the Fort Apache Indian Reservation on roads constructed and maintained by the Bureau of Indian Affairs, the White Mountain Apache Tribe and the logging companies.
