## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Francis Antonio has applied for a tribal loan to remodel his home, and
- WHEREAS, a homesite lease is required by Section 23 (c) II of the Declaration of Policies and Plan of Operation approved September 18, 1962, and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection to the lessee mortgaging the leasehold improvement to the White Mountain Apache Tribe Revolving Credit Program.
- BE IT RESOLVED that the members of the Tribal Council of the White Mountain Apache Tribe do hereby approve and grant a homesite lease to Francis Antonio for a period of twenty-five (25) years with an option for an additional term of twenty-five (25) years at the rate of \$12.00 per year payable annually in advance on the first day of the month following the effective date of the lease with annual payments of like amount on the same date each year thereafter in accordance with the terms of the lease for as long as the lease is in effect.
- BE IT FURTHER RESOLVED that the Tribal Council shall execute said lease for and on behalf of the White Mountain Apache Tribe in accordance with Tribal Ordinance No. 44; the effective date of the commencement of said lease being the date of the approval of the loan by the Secretary of the Interior or his designated representative.
- BE IT FURTHER RESOLVED that should an assignment have been made on the lot which is hereby leased, the lease shall automatically cancel the Assignment.
- BE IT FURTHER RESOLVED that the Tribal Chairman shall approve the leasehold mortgage mortgaging the improvements to the White Mountain Apache Tribe Revolving Credit Program.
- BE IT FURTHER RESOLVED that should the loan not be approved within one hundred eighty (180) days from the date hereof, the lease and approval of right to mortgage the leasehold improvements shall thereby automatically terminate.
