BE IT RESOLVED that effective immediately, the Tribal Chairman's salary shall be \$19,000.00 per annum and the Vice Chairman's salary shall be \$15,000.00 per annum.

BE IT FURTHER RESOLVED in addition, any additional benefits be added to the salaries.

BE IT FURTHER RESOLVED that the Chairman is hereby authorized to increase the Tribal Secretary's salary.

The foregoing resolution was on May 2, 1974 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

We refer to Resolution No. 74-90 enacted by the White Mountain Apache Tribal Council on May 2, 1974, approving increases in salary for the Chairman and Vice-Chairman. This action constitutes an increase to the current tribal budget in excess of \$5,000 since additional benefits are also provided for by the resolution. The resolution further authorizes the Chairman to increase the Tribal Secretary's salary which, it is our understanding, will be taken into consideration in an amended tribal budget to be submitted at a later date.
