- WHEREAS, to operate the Fair and Rodeo Program efficiently, the Chairman advised that a Fair Commissioner should be employed.
- BE IT RESOLVED that the Chairman is hereby authorized to employ a Fair Commissioner at a salary not to exceed \$8,000.00 plus the sum of \$4030.00 as and for office and other expenses.
- BE IT FURTHER RESOLVED that \$12,030.00 be added to the current year's budget and further appropriated from the tribal funds on deposit with the United States Treasury to defray the said above costs.

The foregoing resolution was on July 10, 1974 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i), (s) and (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
