KAY LEWIS to serve as Secretary replacing Reva Truax whose term expires May 16, 1978;

LEROY LUPE to serve as Treasurer and replacing Virgil Kessay whose term expires May 16, 1977;

LAFE ΛΙΤΛΗΛ to replace JoΛnn Hinton and serve until May 16, 1975.

BE IT FURTHER RESOLVED that the council request that the White Mountain Apache Housing Authority notify the Chairman ninety (90) days prior to the need for future reappointments.

The foregoing resolution was on July 10, 1974 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (s) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
