The foregoing resolution was on August 15, 1974 adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Last fall of 1973, the White Mountain Apache Tribe received an invitation from the Federal Regional Council to present program needs and long range goals before the Council. This was discussed with former Tribal Chairman Banashley and also the Tribal Council. It was the feeling at that time that adequate planning had not been done to present the required goals and objectives and long range plans to the Regional Council. As a result of the discussion on the council floor, they decided to defer the presentation to the Federal Regional Council until edequate planning and priority establishments could be done.

Tribal Chairman Lupe received an invitation dated August 12, 1974 from the Federal Regional Council, Region 9, to present to them their needs to the special task force that involves the coordinated interagency response to tribally developed comprehensive plans in establishment of local federal coordinating groups to provide follow up and technical assistance. The Council accepted this, and it was the desires of the Regional Council to meet as early as possible, possibly late September, The Council was agreeable to this and as a result Resolution No. 74-124 was drafted accepting the invitation to have the people from the Regional Council, the Indian Task Force, to visit the reservation and to work with the tribal governing body here at Whiteriver; however, the Tribal Council and the Tribal Chairman neglected to set a specific date for a meeting. Contact will be made with the Tribal Chairman to attempt to have them specify a meeting date that would be satisfactory to the Tribe and a tentative date to the Federal Regional Countil and attempt to get a date either late in September or early October that would be satisfactory to both entities.
