

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, West Anderson, Sr. of Canyon Day Community has requested a business site and lease, and

WHEREAS, the Land Board agreed to assign 0.815 acres of land at Canyon Day, west of Cain Hasting's homesite, and

WHEREAS, the Council is in agreement to grant Mr. Anderson the type of business lease that is standard for tribal members entering business.

BE IT RESOLVED by the Council of the White Mountain Apache Tribe that the business site location and long-term lease be approved on the same terms and conditions as the other leases granted to tribal membership for business purposes.

BE IT FURTHER RESOLVED that the Chairman be authorized to sign any and all documents required for the consummation of the lease.

The foregoing resolution was on August 14, 1974 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (1) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

SUBJECT: Tribal Resolution No. 74-129

Members of the Tribe are showing a greater and greater interest in entrepreneurship. Mr. West Anderson, Sr. came before the Tribal Council and requested a business site and a lease to conduct a business in the Canyon Day Community west of Cain Hastings homsite. The Council was in agreement with Mr. Anderson to issue a long term lease to be approved on the same terms and conditions as the other leases granted to the tribal members for business purposes. This would be a 25-year lease with a 25-year option and the tribe would waive the tribal fees for the first five years and at the end of the five year period there would be an evaluation made to determine if the entrepreneur would be capable of paying the required fees normally collected from business operation.

In light of the tribal policies and encouraging and promoting entrepreneurship the Tribal Council approved and granted Mr. Anderson a long term lease for the purpose of conducting his business. At this time it has not been stated as to what type of business Mr. Anderson is going to get into, but apparently it is going to be a general mercantile to supply the community with the basic needs and eliminate the necessity of traveling to Whiteriver or other parts of the reservation.

The resolution was adopted on August 14, 1974 by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (1) of the Amended Constitution. Under this authority the resolution is not subject to review or approval.
