RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, at the Council meeting of September 11, 1974 there was a discussion on the subject of the Church of Jesus Christ, and

WHEREAS, the action recorded in the minutes of August 14, 1974 were not complete as to the action voted upon, and

WHEREAS, the minutes of the August 14, 1974 meeting were corrected at the meeting of September 11, 1974, and

WHEREAS, the corrected minutes of the September 11, 1974 meeting request that the Superintendent revoke Permit 14-20-OH52-9, and

WHEREAS, this revocable permit was issued on May 1, 1974 by Resolution No. 74-70.

BE IT RESOLVED by the Council of the White Mountain Apache Tribe that the Superintendent revoke Permit 14-20-OH52-9 issued to the Church of Jesus Christ issued May 1, 1974 and signed as Permittee by Isaac D. Smith, Missionary, and Harry Sanchez, Trustee.

BE IT FURTHER RESOLVED that the Church of Jesus Christ be given a 90 calender day period in which to remove from said permit buildings and accessories not connected to the premises.

BE IT FURTHER RESOLVED that upon receipt of cancellation notice of Permit 14-20-OH52-9 the Church of Jesus Christ will vacate the area covered under the permit.

BE IT FURTHER RESOLVED that Resolution No. 74-70 is hereby rescinded in its entirety.

The foregoing resolution was on September 11, 1974 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (1) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**MEMORANDUM**

**SUBJECT:** Tribal Resolution No. 74-136

Resolution No. 74-136 passed by the Tribal Council on September 11, 1974, requested that the Agency revoke Permit No. 14-20-0852-9 issued to the Church of Jesus Christ on May 1, 1974.

Since this had been controversial for a period of two years or so, the church group immediately fenced the area surveyed and established buildings and quarters to be used by the church. After the issuance of the permit there was opposition from some of the reservation residents as to the operation and location of the church.

The matter has not been completely resolved as of this date, but the Agency has the mandate to cancel this revocable permit and give the Church of Jesus Christ a 90 calendar day period in which to remove from the premises all buildings and accessories not connected to the premises.

It is the intent of this office to issue the 90-day cancellation on the above revocable permit immediately upon receipt of the minutes of the council meeting that directed this action on September 11, 1974. Complete file will be forwarded to the Area Realty office and also the office of the Solicitor.
