

RESOLUTION OF THE
 WHITE MOUNTAIN APACHE TRIBE OF THE
 FORT APACHE INDIAN RESERVATION

WHEREAS, a letter from Charles Patterson has indicated to the council that the Agency Roads Project will delay the opening of the North Whiteriver Housing Project, and

WHEREAS, Superintendent Dye has written a letter to the Area Director explaining to him the need for completion of the Sub-Division streets, and

WHEREAS, the Tribe requested in Resolution No. 73-183 dated November 27, 1973 that the Area Office give assistance in order that the project could be started, and.

WHEREAS, the Reservation Roads Committee requested in the presence of a number of the Area Office Staff that the amount of \$60,000.00 be used for this project in the meeting of November 28, 1974, and

WHEREAS, the Tribal Council feels that an obligation was made by both the Superintendent and the Area Office so that the argument with HUD over proto-type cost could be adjusted and the project started.

BE IT RESOLVED by the Council of the White Mountain Apache Tribe that funds be made available out of the present year budget to complete the streets, gutters and sidewalks for the North Whiteriver subdivision.

BE IT FURTHER RESOLVED that the Area or Agency roads construction funds be adjusted to permit construction of the project since housing is an extremely high priority for the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED that the Council of the White Mountain Apache Tribe is extremely disappointed in the action of the removal of the project from the Fiscal Year 1975 priority list and desires that every action be taken to correct the action and construct the project on schedule.

BE IT FURTHER RESOLVED that the Agency Superintendent told the Tribe that the shift in Projects was not done until sometime early this year after the housing project had started.

The foregoing resolution was on November 6, 1974 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

SUBJECT: Tribal Resolution No. 74-161

The Tribal Council amended the road priority list by Resolution No. 73-188 giving the North Whiteriver Subdivision, Arizona project No. 16-18, the top priority for construction of streets, curbs, gutters and sidewalks.

The Council was advised that the projected completion date of construction of the subdivision would be delayed due to removal of the road project from the fiscal year 1975 priority list.

The Council feels that an obligation was made by both the Superintendent and the Area Office so that the argument with HUD over proto-type cost could be adjusted and the housing project started.

The Council in their regular meeting of November 8, 1974 adopted Resolution No. 74-161 that funds be made available out of the FY 1975 budget to complete the streets, gutters and sidewalks for the North Whiteriver Subdivision.

The Tribal Council was extremely disappointed in the action of the removal of the project from the fiscal year 1975 priority list and desires that every action be taken to correct the action and construct the project on schedule.
