

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribal Safety Committee organized, established and approved by Resolution No. 73-73, and
- WHEREAS, the Tribal Safety Committee has functioned without a permanent Tribal Safety Coordinator and/or additional safety programs, and
- WHEREAS, the Tribal Safety Committee is searching for necessary funds to budget the salary of the White Mountain Apache Tribal Safety Coordinator and/or additional expenses of the Tribal Safety program, and
- WHEREAS, the Tribal Safety Committee, at the meeting of October 30, 1974, expressed an opinion that they enter Tribal group membership into National American Indian Safety Council, Inc. (NAISC); and recommends that the Tribal Council of the White Mountain Apache Tribe give their approval of paying a yearly \$15.00 membership to National American Indian Safety Council, Inc. by White Mountain Apache Tribal Safety Committee, as long as it is in existence, and
- WHEREAS, the White Mountain Apache Tribal Safety Committee recommends Council approval of membership to the National American Indian Safety Council, Inc. to greatly benefit the Tribe in safety requirements and regulation as specified under OSHA and state laws of safety, for employees and business entities of the White Mountain Apache Tribe, and
- WHEREAS, the Tribal Safety Committee can function professionally, operate more efficiently as members of the National American Indian Safety Council, Inc. and the possibility of obtaining necessary funds to budget the Tribal Safety program's cost of operation for the ensuing Fiscal Year, 1975-1976.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the White Mountain Apache Tribal Safety Committee is hereby authorized and directed approval to enter membership into National American Indian Safety Council, Inc.
- BE IT FURTHER RESOLVED that the Council Chairman authorize the Tribal Treasurer and Safety Committee Chairman to prepare the necessary payment with yearly dues of \$15.00 to the National American Indian Safety Council, Inc., and each year thereafter, for as long as the Safety Committee remain recognized by the White Mountain Apache Tribal Resolution No. 73-73.
- BE IT FURTHER RESOLVED that the Tribal Safety Committee has assured the Tribe that it will search for necessary funds with the assistance and advice of National American Indian Safety Council, Inc.
- BE IT FURTHER RESOLVED that the Tribal Council authorize the responsibility of Tribal safety for employees and business entities of the White Mountain Apache Tribe to White Mountain Apache Tribal Safety Committee.

BE IT FURTHER RESOLVED that the Tribal Council authorize the Safety Committee appoint a representative from their members of the White Mountain Apache Tribal Safety Committee to the National American Indian Safety Council, Inc.

The foregoing resolution was on November 6, 1974 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) and (s) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**SUBJECT:** Tribal Resolution No. 74-163

The Tribal Safety Committee expressed an opinion that they enter Tribal group membership into the National American Indian Safety Council, Inc. (NAISC). They believe that this will greatly benefit the Tribe in safety requirements and regulation as specified under OSHA and state laws of safety for employees and business entities of the White Mountain Apache Tribe.

Resolution No. 74-163 authorizes and directs approval to enter membership into the National American Indian Safety Council, Inc. It further authorizes the Tribal Treasurer and the Safety Committee Chairman to prepare the necessary payment with yearly dues of \$15.00.

The resolution was adopted on November 6, 1974, by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) and (s) of the Amended Constitution. Under this authority the resolution is not subject to review or approval.
