RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council has accepted the recommendations of the White Mountain Recreation Enterprise for establishing hunting, fishing and camping permits for the 1974-75 seasons, and

WHEREAS, the White Mountain Apache Tribe's interest is in improved game management and increased resource revenues.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the following fee schedule and non-member Fishing - Camping - Hunting Regulations be adopted as attached.

The foregoing resolution was on November 6, 1974 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (f) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

FORT APACHE INDIAN RESERVATION NON-MEMBER FISHING - CAMPING - HUNTING REGULATIONS

(For persons who are not members of the Tribe)

Adopted by the White Mountain Apache Tribal Council November 6, 1974

1. FISHING

Fishing permit fee \$1.50 per day.

Fort Apache Indian Reservation Resident - \$15.00.

Arizona Resident - \$25.00 Out of State Resident - \$35.00

2. CAMP ING

Camping permit fee \$1.00 per day per one unit.

Season: \$100.00 for months of May, June, July and August.

3. BEAR:

Season Dates : April 1, 1975 - May 31, 1975

September 1, 1974 - December 31, 1974

Bag Limit : One bear per valid Arizona License and Reservation

permit per calendar year.

SPECIAL REGULATIONS - The use of livestock, horses, game animals or any part thereof for baiting bears on the Fort Apache Indian Reservation is prohibited.

7. ANTELOPE:

Season Dates :September 21, 22, 23, 1974

Bag Limit : One (1) antelope

Legal Antelope : Buck antelope having horns longer than the ears.

Open Area : 25 A and 25 B

Permit Cost : \$75.00 - Arizona Resident

\$100.00 - Non-Resident

8 <u>ELK</u>:

Season Dates : November 30 - December 8, 1974

Bag Limit : One (1) elk

Legal Elk : Number and species to be determined

Open Area : 25 B - East only

Permit Cost : \$100.00 - Arizona Resident

\$150.00 - Non-Resident

CHRISTMAS TREE LAKE (Closed)

- a. Camping permits are not assignable. If the camper subleases, assigns or permits anyone to gratuitously use his trailer, he shall be ejected from the reservation or his camping fee shall be doubled.
- b. Disposal of all forms of waste water on the ground from campers, trailers, mobile homes are prohibited except at authorized disposal areas. Violators will be prohibited from fishing and/or camping on the reservation for a five-year period.
- c. In all vault-type toilets, no dumping of cans, bottles, plastic bags are allowed. These toilets must be pumped out, it is impossible to pump this trash through a pumper. We are trying to improve our camping facilities for your convenience, your cooperation will be appreciated.
- d. All Reservation guide permits must be Purchased through the White Mountain Recreation Enterprise office, Whiteriver, Arizona.
- e. Live baitfish is prohibited on all waters of the reservation. Anyone caught will be removed from the Fort Apache Indian Reservation for a period of eight (8) years and subject to a fine. This is a very serious offense and is causing the White Mountain Apache Tribe serious problems. We solicit the assistance of any sportsman observing this infraction to make a citizen's arrest and immediately contact any state or tribal game warden or contact the White Mountain Recreation Office in Whiteriver.
- f. A reward of \$50.00 will be paid by the White Mountain Recreation Enterprise for any arrest and conviction.
