- WHEREAS, the White Mountain Anache Tribal Council recognizes that the recent count directed legislative redistricting of the State of Arizona had divided our reservation into two parts, each voting in separate Legislative Districts, and
- WHEREAS, this has resulted in the vatering down of our influence on the election of representatives in either district, and
- WHEREAS, the legislative boundary line presently running straight down the middle street of Maiteriver has not only diluted our ability to have a strong voice in Arizona Lagislative matters, but it has resulted in some confusion in our community, and
- WHEREAS, this confusion is the result of two separate sets of Legislative Candidates compaigning at the same time.
- BD OT RESOLVED that the White Mountain Apache Tribal Council therefore patitions the U.S. District Court to recognize the directing solution to this problem (Senate Bill 1000) passed by the Arizona Legislation and signed by Governor Jack Williams.
- PT IT FURTHER RESOLVED that the boundary lines directed under this bill would remaite the voting power of the White Mountain Apache people and would do away with the confusion and entra cost of two compassing in the same area.

The foregoing resolution was on November 20, 1974 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Acticle V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe, June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
