Clendon, Dewey and Arlene Cromwell, Freddie and Glorinda Dazen, George and Jane Garland, Emily George (divorced), Joyner George (single), Arnold and Laverne Kitcheyan, Ulysses and Leola M. Larzelere, Ronnie and Roxie Nachu, Darrell W. and Cynthis M. Parker, Phillip R. Stago, Jr. (single), and Monte and Aurelia Stover have applied for a loan from the Farmers Home Administration to construct a home, and
- WHEREAS, the Farmers Home Administration requires a residential lease in the names of Lefty and Marjorie (Cody) Alo, Antone and Darlene Antonio, Lavern and Gladys K. Bonito, Marty and Sharon Bush, Carlos and Lucia C. Nosie, Speedy and Orita M. Clendon, Dewey and Arlene Cromwell, Freddie and Glorinda Dazen, George and Jane Garland, Emily George (divorced), Joyner George (single), Arnold and Laverne Kitcheyan, Ulysses and Leola M. Larzelere, Ronnie and Roxie Nachu, Darrell W. and Cynthia M. Parker, Phillip R. Stago, Jr. (single), Monte and Aurelia Stover, the proposed borrowers, and
- WHEREAS, by enactment of Ordinance No. 91, the Tribal Council on May 3, 1972 approved the lease form acceptable to the Farmers Home Administration, and
- WHEREAS, the Tribal Council has no objection to the use of this land by the above-named individuals, and
- WHEREAS, the Tribal Council has no objection to the lessors mortgaging the leasehold improvements to the Farmers Home Administration.
- BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe does hereby grant and approve a residential lease to Lefty and Marjorie (Cody) Alo, Antone and Darlene Antonio, Lavern and Gladys K. Bonito, Marty and Sharon Bush, Carlos and Lucia C. Nosie, Speedy and Orita M. Clendon, Dewey and Arlene Cromwell, Freddie and Glorinda Dazen, George and Jane Garland, Emily George (divorced), Joyner George (single), Arnold and Laverne Kitcheyan, Ulysses and Leola M. Larzelere, Ronnie and Roxie Nachu, Darrel W. and Cynthia M. Parker, Phillip R. Stago, Jr. (single), and Monte and Aurelia Stover, as required by the Farmers Home Administration for a period of twenty-five (25) years automatically renewable to an additional term of twenty-five (25) years.
- BE IT FURTHER RESOLVED that the Chairman of the White Mountain Apache Tribe is hereby authorized to approve the mortgaging of the leasehold improvements as required by the Farmers Home Administration.
- BE IT FURTHER RESOLVED that the Tribal Council is authorized to execute said lease in accordance with Tribal Ordinance No. 91, the effective date of the lease shall be the date of loan closing by the Farmers Home Administration.

BE IT FURTHER RESOLVED that should an assignment have been made on the land which is hereby leased to Lefty and Marjorie (Cody) Alo, Antone and Darlene Antonio, Lavern and Gladys K. Bonito, Marty and Sharon Bush, Carlos and Lucia C. Nosie, Speedy and Orita M. Clendon, Dewey and Darlene Cromwell, Freddie and Glorinda Dazen, George and Jane Garland, Emily George (divorced), Joyner George (single), Arnold and Laverne Kitcheyan, Ulysses and Leola M. Larzelere, Ronnie and Roxie Nachu, Darrell W. and Cynthia M. Parker, Phillip Stago, Jr. (single), and Monte and Aurelia Stover, the lease shall automatically cancel the assignment.

The foregoing resolution was on January 9, 1975 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Cection 1 (b) and (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe, June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
