

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

- WHEREAS, the Arizona Department of Transportation proposes to reconstruct that portion of State Route 73 extending from Mile Post 338 to Mile Post 340 and passing through the community of Whiteriver. The work will include roadway widening, re-alignment through the business section of the community, new surfacing, and sidewalks, and
- WHEREAS, the project will extend from Mile Post 338 to Mile Post 34; a distance of two (2) miles, and
- WHEREAS, a 100 foot right-of-way width is proposed throughout the length of the project, and
- WHEREAS, it is proposed to shift the alignment to the west through the central business area thereby keeping the taking of existing buildings to a minimum. Limits are from a point just north of W. Cypress Street to a point just south of W. Oak Street. The alignment will follow the existing roadway for the remainder of the project, and
- WHEREAS, a curbed island extending from about W. Cypress Street on the south to about E. Sycamore Street on the north is proposed. No median (or island) is proposed for the remainder of the project, and
- WHEREAS, curb, gutter and concrete sidewalk are proposed for the portion of the project extending from W. Cypress Street to E. Sycamore Street, and
- WHEREAS, four traffic lanes are proposed for the full length of the project, and
- WHEREAS, it is proposed that no "on street" parking be permitted throughout the project. There appears to be sufficient vacant land in the central business area to provide for off-street parking. There also appears to be adequate off-street parking already available for the remainder of the project, and
- WHEREAS, it is proposed that a bituminous surface type sidewalk be provided adjacent to each right-of-way line for that portion of the project where concrete sidewalk is not being provided.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Chairman and the Superintendent are hereby authorized and directed to approve the Department of Transportation Project.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Chairman and the Superintendent are hereby authorized and directed to issue a permit to the Arizona Department of Transportation for materials to be used on the project, approximately 45,000 yards to be taken from Pit 8435.
- BE IT FURTHER RESOLVED that the Arizona Department of Transportation shall pay this tribe the following rates computed on a tonnage basis for the removal of said sand and gravel: Six cents (6¢) per ton for all borrow; Ten cents (10¢) per ton for all select; Twelve cents (12¢) per ton for all ABC, MA; and Fifteen cents (15¢) per ton for all cover removed from the premises.

The foregoing resolution was on July 1, 1975 duly adopted by a vote of 8 for and 2 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
