RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is responsible for reviewing final determinations of the Grievance Committee regarding personnel grievances; and
- WHEREAS, the Tribal Council has been presented, for review, with the decision of the Grievance Committee upholding the termination of Isaac Kasey and Reidhead Cosay from the White Mountain Recreation Enterprise; and
- WHEREAS, the Tribal Council has adduced the statements of said terminated employees and reviewed the available information surrounding said termination and the operations of the White Mountain Recreation Enterprise; and
- WHEREAS, the Tribal Council finds that said employees have provided years of service and experience to the Tribe as White Mountain Recreation Enterprise employees, which warrants Council scrutiny upon their current termination status.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe, hereby directs that Isaac Kasey and Reidhead Cosay are hereby reinstated as employees of the White Mountain Recreation Enterprise with back pay pending further hearing and decision by the Tribal Council at an executive session to be held Monday, January 8, 1979, at the Tribal Council Chambers.
- BE IT FURTHER RESOLVED that the determination of the Grievance Committee in this matter is hereby suspended pending any further action by the Tribal Council at its Executive Council Meeting.

The foregoing resolution was on January 3, 1979, duly adopted by a vote of 6 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
