## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council is aware that the present Day Care Center building in Whiteriver is built out of cinder block, which is exposed on the inside of the exterior walls, and
- WHEREAS, the Center's Parent Advisory Board has presented a request to the Council for funding in the amount of \$3,280.00, as set forth in the attached proposal from Development Enterprise, and
- WHEREAS, said amount will provide for the finishing of the inside of the exterior walls at the Day Care Center.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the construction work on the Day Care Center in Whiteriver, as hereinabove described.
- BE IT FURTHER RESOLVED that the Tribal Council authorizes and directs the Central Business Office to make the expenditure herein described, in the amount of \$3,280.00, from Revenue Sharing Funds on hand.

The foregoing resolution was on March 18, 1980 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
