

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the White Mountain Apache Tribe is undertaking an intensive program of irrigation and agricultural development and, in addition, is continuing a long-term expansion of its basic forestry industry, and

WHEREAS, in pursuit of these vital economic development objectives the White Mountain Apache Tribe requires large sums of money to defend its interests in the areas of rights protection, environmental services, water resources and minerals and mining, and

WHEREAS, the Bureau of Indian Affairs annually appropriates substantial sums of money for Indian tribes in support of Federal responsibilities for Tribal natural resources, including the following vital resource categories:

- Mineral and Mining
- Water Resources
- Environmental Services
- Rights Protection

these accounts having been funded in the Bureau of Indian Affairs Fiscal Year 1981 budget, with substantial amounts allocated to the Phoenix Area Office and none to the Fort Apache Agency.

BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe hereby requests that the Bureau of Indian Affairs Phoenix Area Office provide to the Tribe detailed information as to the sums available under the above-listed accounts for contracting or direct grant to the White Mountain Apache Tribe - providing also specific guidance for initiating said contracts, grants, or other funding arrangements.

BE IT FURTHER RESOLVED that the White Mountain Apache Tribal Council hereby authorizes the Tribal Chairman to initiate negotiations immediately to obtain the necessary funds to support essential activities in the above-listed areas of Tribal interest.



Subject: Tribal Resolution No. 80-218

The Tribal Council has been advised that the Arizona Department of Economic Security will allocate fiscal year 1980 Comprehensive Employment Training Act, Title IIB Funds in the amount of \$192,424.00 to the White Mountain Apache Tribe. These funds will allow tribal members attending the Phoenix Indian School, Sherman Indian School, Stewart Indian School, Inter-Mountain Inter-Tribal Indian School and local area schools to enroll in the CETA Program.

Resolution 80-218 authorizes the submittal of a grant proposal under the fiscal year 1980 CETA Title IIB Program (and in all Title IIB allocations) with the objective of providing the maximum possible number of work experience enrollee positions and on-the-job training positions.

The resolution also authorizes and directs the Tribal Chairman to sign any and all documents necessary to carry out this resolution.

The resolution was adopted on August 1, 1980, by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution. Under this authority the resolution is not subject to review or approval.
