WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been requested by the Diamond Creek Community to provide necessary funding for the purpose of repairing and remodelling Diamond Creek Community Building, and


WHEREAS, the Tribal Council is fully informed that such community building is in a state of substantial disrepair, and


WHEREAS, the Tribal Council is advised that the estimate cost of repairs of the building is \$11,498.00 a copy of which is attached here, and

WHEREAS, the Tribal Council finds it appropriate to use the Revenue Sharing Funds for community development projects such as this request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes and directs the expenditure of \$11,498.00 from Revenue Sharing Funds, Fiscal Year 80/81 for the purpose of repairing and remodelling the Diamond Creek Community Building.

The foregoing resolution was on December 03, 1980 duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
