RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT AFACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that the two revocable permits covering highway maintenance camps on the reservation must be renewed with the Arizona Department of Transportation because they have expired; and
- WHEREAS, one of these camps is the Indian Pine Maintenance Camp located across the highway from the Hondah Service Station which expired on October 31, 1981; the second camp being the Flying V Maintenance Camp located on the west side of U.S. Highway 60, about 10 miles north of the Salt River Canyon, which expired on June 30, 1981; and
- WHEREAS, the Department of Transportation is agreeable to paying the annual fee of \$400.00 per year for the Flying V Maintenance Camp commencing December 1, 1981, with an expiration date of October 31, 1986; and
- WHEREAS, the Arizona Department of Transportation is agreeable to paying the annual fee of \$800.00 for the Indian Pine Maintenance Camp; and
- WHEREAS, the fee of \$800:00 per year for the Indian Pine Maintenance Camp is below the appraisal rent calculated by the Bureau of Indian Affairs; and
- WHEREAS, Title 25, Part 131.52 provides that in the discretion of the Secretary of the Interior, tribal land may be leased at a nominal rental below the appraisal rate to federal, state or local governments for purposes of subsidizing for the benefit of the tribe; and
- WHEREAS, the Tribal Council has been advised that the Arizona Department of Transportation has received severe budgetary cuts in the amount of \$68,000,000 leaving little or no money to pay for maintenance camps; and
- WHEREAS, the Indian Pine Maintenance Camp provides an extremely valuable service to the White Mountain Apache Tribe and the operation of its Sunrise Ski Resort as well as access to Whiteriver from Route 260, as well as to businesses between Show Low and Hondah; and
- WHEREAS, the Tribal Council concludes that it would be in the best interest of the Tribe to renew the revocable permits for the Flying V Maintenance Camp and the Indian Pine Maintenance Camp.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Chairman to execute new revocable permits for the Indian Pine Maintenance Camp and the Flying V Maintenance Camp for a period of five (5) years pursuant to the annual rental fees set forth herein.

BE IT FURTHER RESOLVED that the Tribe requires the State Highway

Department employees will not trespass beyond the boundaries
of the permit area.

The foregoing resolution was on January 7, 1982, duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
