## RESOLUTION OF THE WHITE MOUNTAIN AFACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, pursuant to Section VI, (C), of Tribal Ordinance 56, as amended, the Tribal Council, assembled in open meeting, has completed a recount of the votes cast in the 1982 Tribal Election for Tribal Chairman and for the Councilman position in District II, pursuant to a request by Tribal Chairman Candidate, Phillip R. Stago, Jr. and Tribal Councilman Candidate, Gertie Lupe for District II; and
- WHEREAS, the Tribal Council directed the Election Board Committee to complete the recount procedure according to the procedures and conditions set forth in Resolution No. 82-69; and
- WHEREAS, a final abstract of the votes for the position of Tribal Chairman and Councilman for District II, has been completed by the duly delegated Election Board Committee and is attached to this Resolution and incorporated by reference herein; and
- WHEREAS, pursuant to Section VI, (D), of Tribal Ordinance 56, as amended, the Tribal Council shall upon a completion of the recount and receipt of the final abstract, declare said recount abstract as final and declare the candidate with the highest vote to be elected.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby declares, pursuant to Section VI, (D) of Ordinance 56, as amended, that Ronnie Lupe is the Candidate with the highest vote for Tribal Chairman Position and is hereby declared to be elected to the Position of Tribal Chairman of the White Mountain Apache Tribal Council.
- BE IT FURTHER RESOLVED by the Tribal Council that the White Mountain Apache Tribe pursuant to Section VI, (D) of Ordinance 56, as amended, that it hereby declares Lafe Altaha as the Candidate for District II Councilman with the highest vote for said position and is hereby declared to be the elected Councilman for District II.

The foregoing resolution was on April 13, 1982, duly adopted by a vote of 6 for; 0 against; 4 abstention by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a, i, s, t, and u) and Article VIII, Section 8, of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
