



RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the General Manager for the Sunrise Ski Park has advised the Tribal Council that the recent expansion of the Ski Area known as Apache Peak has increased the volume of skiers to the Sunrise Ski Area and has necessitated the use of shuttle buses to transport skiers from the hotel and from the day lodge area to the Apache Peak Ski Area, and
- WHEREAS, the volume of skiers has been so great that the Sunrise Ski Area has been required to hire a ski shuttle service operating out of Pinetop in order to accomodate the skiers, and
- WHEREAS, the manager of the Sunrise Ski Park believes that it is in the best interest of the Tribe to hire tribal employees to perform this work and to purchase a forty passenger shuttle bus to be operated by the tribal members for purposes of transporting skiers to day lodge, main hotel and Apache Peak Ski Area, and
- WHEREAS, there is one bus available for purchase in the Denver, Colorado area for \$51,000.00 but if that bus is not purchased the Ski Area will have to order a bus which will take 150 days to deliver to the ski area, and
- WHEREAS, the need is greatest for the shuttle bus during the height of the ski season which is between January 1st and April 15th, 1983, and
- WHEREAS, the purchase of the bus will create two jobs for tribal members and said bus has been planned to be purchased out of the next year's budget in any event but is necessary now in order to maintain the quality of service to the skiing public and to create immediate employment for tribal members, and
- WHEREAS, the Tribal Council agrees that said bus should be purchased immediately for this ski season.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants authority and permission to the General Manager of the Sunrise Ski Area to purchase the shuttle bus for the purposes set forth in this resolution and to hire the necessary tribal member personnel to operate said shuttle bus.
- BE IT FURTHER RESOLVED by the Tribal Council that it authorizes the Tribal Chairman to execute any and all documents necessary to carry out the purposes of this resolution.

BE IT FURTHER RESOLVED by the Tribal Council that line item budget be increased in an amount equal to the cost of the bus.

The foregoing resolution was on January 5, 1983, duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
