## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the anticipated income of the White Mountain Apache Tribe for the Fiscal Year beginning May 01, 1983 and ending April 30, 1984 will be \$5,244,001.00 \_\_\_\_\_, and
- WHEREAS, in order to provide funds for the continuation of certain tribal activities including education and welfare purposes for members of the White Mountain Apache Tribe as well as development, protection and conservation of the reservation resources and for other purposes during the 1983-84 Fiscal Year at a budgeted cost of \$4,940,476.00 for operations and \$185,702.00 for fixed assets, and
- WHEREAS, the Tribal Council concludes tentative approval of the Central Tribal Budget is appropriate at this time, subject to further recall, review and rejection by the Tribal Council in whole or in part in the exercise of its sound discretion and Constitutional authority.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache
  Tribe that it hereby grants tentative approval of the Central
  Tribe's Operating Expense in the amount of \$4,940,476.00
  and Capital Expenditure amounting to \$185,702.00 for
  the Fiscal Year beginning May 01, 1983 and ending April 30,
  1984, subject to further recall, review and rejection by the
  Tribal Council in whole or in part in the exercise of its
  sound discretion and Constitutional authority.
- BE IT FURTHER RESOLVED by the Tribal Council that it is hereby authorized and appropriated from Tribal funds placed on deposit with the Treasury of the United States the sum of\$5,126,178.00. These funds are to be expended in accordance with the items listed in the budget attached hereto and made a part hereof.
- BE IT FURTHER RESOLVED that the Tribal Treasurer shall make disbursements of Tribal funds appropriated herein and only upon signatures authorized by the properly designated tribal employees and approved by the Chairman and the Administrative Manager.
- BE IT FURTHER RESOLVED that the budget be reviewed every ninety (90) days and that the Treasurer shall not approve expenditures unless funds or the expenditures are in the Tribal Account.
- BE IT FURTHER RESOLVED that all remaining unobligated balances as of April 30, 1983 are hereby cancelled and such unobligated balances shall be returned to the General Account of the Tribe.

The foregoing resolution was on May 10, 1983 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i & k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
