WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been presented with a list of tribal members requesting specific home-site assignments, and

WHEREAS, the Tribal Council reviewed the applications recommended for approval by the committee, and

WHEREAS, the list of tribal members, with description of specific locations is attached hereto.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the homesite applications as recommended by the Land Board.

The foregoing resolution was on September 07, 1983 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
