RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has been advised that pursuant to ARTICLE IX, Section 1 and 3 of the Constitution and By-Laws of the White Mountain Apache Tribe, that if any member of the Tribal Council fails or refuses to attend two (2) Regular Council Meetings in succession, unless excused due to illness or other causes for which he cannot be held responsible, that he shall forfeit his or her office and that the Tribal Council shall declare the position vacant, and
- WHEREAS, the Tribal Council is further advised that pursuant to the Constitutional provisions set forth above, the vacancy so declared shall be filled "at once" by a majority vote of the Tribal Council, and
- WHEREAS, it has been determined, in accordance with the Constitution and By-Laws, that the Councilman position now occupied by Mr. Rudy Walker, Sr. must by Constitutional mandate be declared vacant, and
- WHEREAS, it is the Constitutional duty of the Tribal Council to appoint at once, pursuant to ARTICLE IX, Section 3, a person to serve the unexpired term of the Office or member, whose position has been declared vacant by the Council pursuant to ARTICLE IX, Section 1 of the Constitution, and
- WHEREAS, after a lengthy discussion, it is the majority opinion that Mr. Carlos Nosie should be appointed to serve out the unexpired term of the Councilman position declared vacant herein, and
- WHEREAS, the Tribal Council hereby declares Councilman Rudy Walker, Sr.'s position vacant pursuant to ARTICLE IX, Section 1 of the Constitution and By-Laws of the White Mountain Apache Tribe, and
- WHEREAS, the Tribal Council hereby appoints Carlos Nosie to serve out the unexpired term of Mr. Rudy Walker, Sr.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to the Constitutional mandate set forth in ARTICLE IX, Section 3 of the Constitution, it hereby appoints Carlos Nosie to serve out the unexpired term of the Councilman position described herein for District II, East Fork-Turkey Creek and Seven-Mile.
- BE IT FURTHER RESOLVED by the Tribal Council that appointee Carlos Nosie is hereby directed to appear before the Tribal Council Meeting now scheduled for January 18, 1984 to be sworn in pursuant to this appointment.

The foregoing resolution was on January 12, 1984 duly adopted by a vote of 5 for 2 abstention and 0 against by the Tribal Council of the White Moutnain Apache Tribe, pursuant to authority vested in it by Article IX, Section 1 & 3 of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on Msy 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
