

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Mr. Bill Perez, Acting Manager of the I. D. Ranch, a Tribal Enterprise, has come before the Tribal Council with a request that he be considered as the permanent Manager of the ranch in view of Dan Troncali's resignation and move to Tucson, Arizona, and

WHEREAS, Mr. Perez explains to the Council that he would like to move some personal equipment, as well as, his family to I. D. Ranch and would like some guideline from the Council as to his term of employment before he makes any further moves, and

WHEREAS, the Tribal Council, after some discussion with Mr. Perez as to his background in livestock and ranch management concludes that he should be given the opportunity to perform the duties of General Manager for a period of one year, the contract to be extended if the Tribal Council is satisfied with his performance, and

WHEREAS, the Tribal Council concludes further that Mr. Perez should enter into a contract for the same salary as he is now receiving as Acting Manager and that he should receive his lodging and certain other personal items as part of his salary, the specific terms to be negotiated between the Tribal Attorney and Mr. Perez subject to approval of the Tribal Chairman, or in his absence, the Vice-Chairman, and

WHEREAS, the Tribal Council also requests that Mr. Perez, as one of his first duties conduct a head count of the cattle owned by the I. D. Ranch and to report the results of said head count to the Tribal Administrative Manager and the Offices of the Chairman and Vice-Chairman.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a one-year contract for Bill Perez as the General Manager of the I. D. Ranch at the salary of \$16,000.00 per year with other fringe benefits to be determined and negotiated by the Tribal Attorney and Bill Perez subject to the approval of the Tribal Chairman and in his absence, the Vice-Chairman.

BE IT FURTHER RESOLVED by the Tribal Council that it requests that Bill Perez as one of his first duties, conduct a head count of all of the cattle owned by the I. D. Ranch and submit a list of this head count to the Business Manager, Don Booker, and the Tribal Chairman and Vice-Chairman.

The foregoing resolution was on June 6, 1984 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
