

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the anticipated income of the White Mountain Apache Tribe for the Fiscal Year beginning May 01, 1984 and ending April 30, 1985 will be \$7,607,400.00; and

WHEREAS, in order to provide funds for the continuation of certain tribal activities including education and welfare purposes for members of the White Mountain Apache Tribe as well as development, protection and conservation of the reservation resources and for other purposes during the 1984-85 Fiscal Year at a budgeted cost \$6,826,048.00 for operations and \$510,722.00 for capital assests; and

WHEREAS, the Tribal Council concludes that approval of the Central Tribal Budget is appropriate at this time;

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants approval of the Central Tribe's Operating Expense in the amount of \$6,826,048.00 and Capital Expenditures amounting to \$510,722.00 for the Fiscal Year beginning May 01, 1984 and ending April 30, 1985; and

BE IT FURTHER RESOLVED by the Tribal Council that it is hereby authorized and appropriated from Tribal funds placed on deposit with the Treasury of the United States the sum of \$7,336,770.00 These funds are to be expended in accordance with the items listed in the budget attached hereto and made a part hereof.


BE IT FURTHER RESOLVED that the Tribal Treasurer shall make disbursements of Tribal funds appropriated herein and only upon signatures authorized by the properly designated tribal employees and approved by the Chairman and the Administrative Manager.

BE IT FURTHER RESOLVED that the budget be reviewed every ninety (90) days and that the Treasurer shall not approve expenditures unless funds or the expenditures are in the Tribal Account.

BE IT FURTHER RESOLVED that all remaining unobligated balances as of April 30, 1984 are hereby cancelled and such unobligated balances shall be returned to the General Account of the Tribe; and

BE IT FURTHER RESOLVED that this resolution supersedes Council Resolution No. 84-136, which is hereby rescinded.

The foregoing resolution was duly adopted on 07-25-1984 by a vote of 7 for 3 abst. and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
