# RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the delivery of human services to the elderly and to persons with various disabilities is a priority of the White Mountain Apache Tribe, and
- WHEREAS, Elderly and disabled persons have difficulty in accessing such services because of a lack of available transportation, and
- WHEREAS, providing for the delivery of human services in the field is dependent upon safe, reliable vehicles, and
- WHEREAS, the Northern Arizona Council of Governments through the Arizona Department of Transportation allows for a grant of funds towards the purchase of vehicles for the delivery of human services.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby requests funding from the Northern Arizona Council of Governments for one such vehicle, to be applied for by the Tribal Human Service Center for use by the Tribal Elderly Program as set forth in the attached proposal.

The foregoing resolution was on January 30, 1985 duly adopted by a vote of 7 for and 0 against, 3 abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

## FUNDING PROPOSAL ABSTRACT

### PROJECT DESCRIPTION:

This is proposal for a van equipeed with a lift and a raised roof to transport the elderly and handicapped in wheelchairs.

## PURPOSE (EXPECTED BENEFIT):

Transportation will be available for those who have special needs of the handicapped. It would be used by the Elderly services, Human Service Center who provide meal services, home care, recreation and transportation for special needs.

### AREA OR COMMUNITY OF IMPACT:

Presently we have approximately twenty wheel-chair patients located in all areas of the Reservation.

## FUNDING SOURCE AND AMOUNG:

\$ 24,442.00 80% of the Funding amount will be paid by Arizona Dept. of Transportation.

## REQUIRED TRIBAL MATCHING FUNDS (SOURCE AND AMOUNT):

\$ 4,888.00 is 20% local contribution (cash match by the Tribe).

#### LONG-TERM TRIBAL COMMITMENT:

Operation cost of the vehicle will come from Title XX - Title III for the Elderly & Handicapped
