RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, by previous resolution, the Tribal Council approved the budget for the White Mountain Apache Enterprise which included the transfer of the Number 10 Liquor License from the Carrizo store to the Enterprise store to be opened at the bottom of the Salt River Canyon; and
- WHEREAS, the Tribal Council is advised that the Arizona State Legislature has prohibited the transfer of all liquor licenses except for Number 6 and 9 licenses, and that an original application must be made to the State Liquor Department of Licenses and Control for the Salt River Canyon Store; and
- WHEREAS, the Enterprise Manager instead requests that the Council approve a Number 7 License and waive the 20-day posting period usually required prior to the approval for a Number 7 Liquor License at that location; and
- WHEREAS, the Number 7 License will allow the on premise consumption of beer and wine at picnic tables on the premises; and
- WHEREAS, the Tribal Council concludes that it would be in the best economic interest of the White Mountain Apache Tribe to approve the application by the White Mountain Apache Enterprise for a Number 7 License at the Salt River Canyon Store.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and authorizes the White Mountain Apache Enterprise Liquor Control Agent to apply for a Number 7 License for the sale of alcoholic beverages at the Salt River Canyon Store.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby waives the 20-day posting period usually required prior to the approval of said license.

BE IT FURTHER RESOLVED by the Tribal Council that although it is authorizing the Enterprise to apply for a Number 7 Liquor License from the Arizona State Department of Liquor Licenses and Control, this authorization shall not be considered a waiver of the sovereign immunity of the White Mountain Apache Tribe for any purpose and does not constitute a concession on the part of the White Mountain Apache Tribe to the jurisdiction and authority of the State of Arizona Department of Liquor Licenses and Control, but should be considered as an act of courtesy and comity between the Arizona State government and the tribal governing body of the White Mountain Apache Tribe.

The foregoing resolution was on June 20, 1985, duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984)
