WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been presented a list of tribal members who request specific homesite assignments, and


WHEREAS, the list of tribal members, with a description of specific locations requested is attached.

The foregoing resolution was on February 5, 1986 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
