FORT APACHE INDIAN RESERVATION

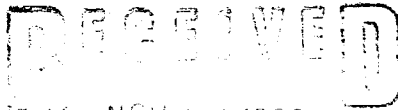

WHEREAS, the Tribal Council has reviewed each and every land proposed assignment and concludes that there is no legal reason why the requested land assignments should not be granted; and

WHEREAS, said Land Board Meeting Minutes and the requested land assignments are attached to this resolution and are incorporated by reference herein.



The foregoing resolution was on November 7, 1986, duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
