WHEREAS, the Tribal Council is of the opinion that Tribal Ordinance Number 60 should be amended in order to bring said Ordinance into conformance with recent Tribal Council resolutions concerning tribal taxation and license fees; and

WHEREAS, the Tribal Council concludes that proposed amendment to Ordinance 60 should be posted for public comment for a period of at least ten days as required by the Tribal Constitution in the form attached hereto and incorporated by reference herein.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Tribal Council Secretary to post the proposed amendment to Ordinance Number 60 for a period of at least ten days as required by the Tribal Constitution.




PROPOSED ORDINANCE OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

BE IT ENACTED by the White Mountain Apache Tribal
Council in Council assembled:


1. That Ordinance Number 60 be amended by revising
Section 15(b) to read as follows:

Fees: A license tax fee of one-percent (1%)
of the total contract value of any contract
for construction activities entered into by
any person, firm or corporation, or other
entity, shall be paid prior to performing any
of the work as provided in Section 15(a).

The foregoing proposed amendment to Ordinance Number 60
was on November 14, 1986, duly enacted by a vote of ten for
and one against by the Tribal Council of the White Mountain
Apache Tribe pursuant to authority vested in it by Article V,
Section 1 (i), (o) of the Amended Constitution and Laws of
the Tribe, ratified by the Tribe on June 27, 1958 and approved
by the Secretary of the Interior on May 29, 1958, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
