RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council is advised by the Bureau of Indian Affairs that the Tribal Council must approve the contractual site of timber from the following two timber sale units: (1) Cibecue and (2) Reservation Salvage III, in order to allow the Fort Apache Timber Company, owned and operated by the White Mountain Apache Tribe, to harvest timber from said sale units; and

WHEREAS, the Tribal Council has adopted a schedule of reduction of the annual allowable cut for the next five years for the Fort Apache Timber company as follows:

WHEREAS, the Tribal Council of the White Mountain Apache Tribe authorizes the following logging units, as presented in the proposed contracts, for the sale of timber, and subject to minor changes and administrative adjustments by the Approving Officer, be sold to the Fort Apache Timber Company as described below:

- WHEREAS, said reduction of the annual allowable cut is, in the Tribe's view, in conformity with the congressional mandate that Indian forests be maintained and harvested on a sustained yield basis; and
- WHEREAS, said reduction of the annual allowable cut to 45 million board feet, in the Tribe's view, represents the permissible annual allowable cut based upon the scientific analysis and sound forestry principles as the maximum allowable cut for the Fort Apache Indian reservation; and
- WHEREAS, the White Mountain Apache Tribe will suffer a sharp reduction of income as well as unemployment resulting from the reduction of its annual allowable cut to 45 million board feet; and
- WHEREAS, the Bureau of Indian Affairs PAO has represented that it will support the White Mountain Apache Tribe in their efforts to obtain a timber supply from outside the reservation to maintain employment and income from the production of forests products at their present levels due to the prior practice of harvesting 93 million board feet annually; and
- WHEREAS, the White Mountain Apache Tribe further desires to increase the Bongberg-Hall Risk Point Rating to six (6) risk points for all cut ponderosa pine, and utilize presently approved cutting prescriptions for non-ponderosa pine coniferous species on the Reservation for the Cibecue Sales; and
- WHEREAS, the White Mountain Apache Tribe further desires to maintain the Bongberg-Hall Risk Point Rating to eight (8) risk points for all salvage cut ponderosa pine, and utilize presently approved cutting prescriptions for non-ponderosa pine coniferous species on the Reservation for Reservation Salvage III Timber; and
- WHEREAS, the Tribal Council's adoption of this resolution does not constitute willing acceptance of the 1985 Forest Management Plan for the Fort Apache Indian Reservation prepared by the BIA, but rather is mandated by the critical necessity to provide logs for the on-going operation of the Whiteriver and Cibecue Sawmills.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Chairman and the Secretary of the Tribal Council, to execute the aforenamed timber sale contracts subject to the provisions of this resolution.

BE IT FURTHER RESOLVED that a deduction not to exceed fifteen percent (15%) of the gross receipts received from the Purchaser, will be accrued in the Road Suspense Account. This accrual will continue until the Road Suspense Account is funded to the extent required to provide the road construction fund reserve authorized by the Tribe.

The foregoing resolution was on February 18, 1987, duly adopted by a vote of SIX for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
