WHEREAS, Mr. Raymus Albert has come before the Tribal Council and has reviewed the minutes of the Tribal Land Board meetings of March 6, 1987 and March 13, 1987, and

WHEREAS, the Tribal Council is of the opinion that the minutes of these meetings are appropriat and should be accepted and the actions taken by the Land Board approved; including the granting of tribal member homesites.

THEREFORE BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe hereby accepts the minutes of the Land Board meetings of March 6, 1987, and March 13, 1987, and approves the actions taken thereby, including the granting of tribal member homesites.

The foregoing resolution was on March 19, 1987, duly adopted by a vote of SIX for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

LAND BOARD MEETING MINUTES

March 6, 1987

The newly selected Land Board Members had their first meeting on March 6, 1987. The members are as follows: Chairman Slim Quay, Vice Chairperson Lula A. Ivins, Members Edward Walker, Sidney Baha.

Members present were Slim Quay, Lula A. Ivins and Edward Walker. Sidney Baha was absent. The Chairman's office reported that Melvin Narcisco declined being member of the Land Board.

Others present were: Raymus Albert, McDaniel Declay, Jerlyn Walker, Frederick Cosay and Lowell Walker.

Chairman Slim Quay opened the meeting at 9:30 a.m.

Frederick Cosay requested that his application for a homesite in North Fork be approved. He said his previous application was given to the Land Board but was lost. The Board approved his application.

Chet Colelay asked about his application, he was told that it was denied because he has a lot already and to resubmit his application.

Lowell Walker requested an assignment in Fort Apache By Carl Nosie's farmland. He was told that it might belong to Carl, he then left to talk to Carl. He then brought in a map drawn by Carl and said Carl said he doesn't own the land. He was told to make an application and to check with the I.D. Board for approval.

LAND BOARD MEETING MINUTES

March 13, 1987

A regular monthly scheduled Land Board Meeting was held on March 13, 1987 in the Tribal Executive Conference Room.

Members present were: Chairman Slim Quay, Vice Chairperson Lula Ivins, Sidney Baha and Edward Walker. Member representing Cibecue District still vacant. (Others present see attachment)

The meeting was opened by Chairman at 9:00 a.m.

Erma Garcia requested her application for an addition to her lot be approved. She was told that area has already been subdivided and it has been assigned. After a long discussion she said she will contact the Housing for resurvey of her lot and then she will decide what to do.

Reva Thompson also requested an addition to her lot. Edward requested that McDaniel check out the area first.

Roy Tenijieth asked about his application for a farmland. He was told that it might have been tabled at the last meeting. Also Fernando and Lorene applications for homesites, they were approved by the Board.

Angela Cheney said she came to discuss her land on which Harry Brewer is living on now. She wants to have her land reassigned to her but she will wait until the next meeting.

Gertie Lupe requested to meet with the Board to present the applications that she still has and also to give the Board some copies of minutes and other information they might need. The Board decided to meet with her on March 27th.

Georgianna Siow asked about her application which she says is for her son. She was told that it was denied because she already has a lot and her son has to apply for a lot himself. She was given an application for her son. Also she wanted to know who clears land, she said she went to D.E. and Farm but they don't do that and was told to check with the Chairman which she wasn't able to do. The Board told her that they only take care of land assignments.

Rosalie Ethelbah requested her farmland application be approved. Her application will be presented to the Board later on.

Angela Moody and Rainbolt Bush had applied for the same area in East Fork. After a long discussion they decided to apply for the area behind Rainbolt's house and behind Martin Dale's house with the wash as a middle boundary. Both of their applications were approved.

Bruce Rustin asked about his application for a farmland by his house. He was told that the area was already assigned and to apply for another area.

Dave D. Massey requested a homesite assignment by his father's house in East Fork. His application was approved.

Lupita Williams asked about her application which was denied at the last meeting because it might have Nancy Nash's name on it. She said Nancy said she didn't have an assignment and that the land was given to her by her grandmother. Lula Ivins will check this out with Lupita's relatives and find out if it was assigned.

Priscilla Goklish asked about her application. It was approved by the Board.

Thelena Albert requested an addition to the S.C.F. office assignment and also for her two daughters an assignment at Rainbow City. No action was taken for the S.C.F. addition. Her daughter Manuelita Canty's application was approved. Thelena Hoffman's application for an assignment in the pond area was tabled. The Board said the area might be contaminated and there might be a problem with drainage of the pond. This will be check out first before it can be assigned. She was given another application for her daughter.
