

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the White Mountain Apache Tribe has updated its road construction priorities; and

WHEREAS, the White Mountain Apache Tribe have agreed to and established its road construction priorities as follows:

1. Consolidated Project 19, completed housing projects in need of paved streets, i.e. H.U.D. Project 16-30 (Southwest and North Diamond Creek East and West of Highway 273), Access Road to H.U.D. Project 16-40 and 42, and access roads serving the numerous homesites in the Alchesay Flat area. [a) Power line road and; b) Frontage Road from Round Top turn-off to Harry Brewer's access road), and Lupe Drive (access road to Mowell Lupe's and it also serves several other homesites)].
2. Footbridge - (A) Old Orchard site - Whiteriver, (B) 7-Mile, (c) Cibecue.
3. Safety Allocation - \$50,000/year.
4. Fairgrounds parking area and Cedar Creek rodeo access - add to BIA Road system for maintenance.
5. White Mountain Apache Housing "87" (Whiteriver and Cibecue overlay streets for housing projects).
6. School Crossing - Overhead walkway in Whiteriver.
7. Route 12 - Improve road from Cibecue to Grass-hopper.
8. Route 55 - Improve road through section of road known as the "Narrows".
9. Route 48 - Improve road from Amos Ranch to Forestdale.
10. \* R-14 - construct new road from Cedar Creek to Cibecue turnoff on Arizona Highway 60; and  
  
\* Would require special appropriations separate from the annual construction monies.

WHEREAS, the White Mountain Apache Tribe requests that the BIA construct the projects as listed above; and

WHEREAS, the priorities may be changed by the Roads Committee and Tribal Council, and it is recognized that priority changes can result in project delays of about 18 months.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the above priority listing.

The foregoing resolution was on June 4, 1987, duly adopted by a vote of EIGHT for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (f) & (g) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
