RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribe has recognized housing access roads to be of a high priority, Resolution 84-14; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-of-way 50 feet in width for a distance of 1383 miles in length and 60 feet in width, a distance of .380 miles for a total distance of .763 miles for completed housing projects and their access roads at North Diamond Creek east of Highway 273 as filed, Drawing #FA-1-13 in the office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous rightof-way 40 feet in width for a distance of .176 miles,
 50 feet in width, a distance of .503 miles, 70 feet in
 width a distance of .459 miles and 80 feet in width, a
 distance of .030 miles for a total distance of 1.168
 miles for completed housing projects and their access
 roads at North Diamond Creek west of Highway 273 as
 filed, Drawing FA-1-14 in the Office of the Superintendent of the Fort Apache Agency, Whiteriver,
 Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-ofway 35 feet in width, a distance of .314 miles in length for completed housing projects at Lifesavers Subdivision, Dark Shadows Road as filed, Drawing FA-1-12 in the office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-ofway 45 feet in width for a distance of 0.122 miles in length for completed housing projects at Canyon Day Bead Loop, as filed, Drawing FA-4-4 in the Office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-ofway 40 feet in width for a distance of .655 miles in length, for completed housing projects at Knots Landing Subdivision as filed, Drawing FA-1-11 in the Office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-ofway 60 feet in width for a distance of .178 miles in length for completed housing projects at Bean Pot Road

as filed, Drawing FA-1-15 in the Office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and

- WHEREAS, the Tribe wishes to consent to a gratuitous right-ofway 60 feet in width for a distance of .248 miles in length, for completed housing projects at East Fork Bush Flat Loop as filed, Drawing FA-7-2 in the office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to consent to a gratuitous right-of-way 50 feet in width, for a distance of .620 miles in length; 60 feet in width for a distance of .677 miles in length; 80 feet in width for a distance of 1.345 miles; 100 feet in width for a distance of 0.082 miles, for a total distance of 1.724 miles in length for completed housing projects at Southwest Subdivision as filed, Drawing FA-1-10 in the Office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it acknowledges the priority of access roads of its members.
- BE IT FURTHER RESOLVED that the Tribal Council hereby consents to gratuitous rights-of-way and requests that the above designated streets be added to the Bureau of Indian Affairs Federal Aid Indian Road System to which reference has been made in the Whereas sections of this resolution, as as recorded on file in the Office of the Superintendent of the Fort Apache Agency, Whiteriver, Arizona.

The foregoing resolution was on April 27, 1988, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1(i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
