RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribal government is charged with the responsibility of administering certain programs for the benefit of tribal members; and
- WHEREAS, the Tribal Social Services Program is in need of new office facilities because of the deteriorating condition of its current location at the old hospital; and
- WHEREAS, a request has been made to the Bureau of Indian Affairs for assignment to the Tribe of certain government quarters to be utilized as office space in the provision and operation of this vital tribal program; and
- WHEREAS, property use agreements have been prepared which temporarily transfer to the Tribe's possession, BIA government quarters Nos. 24, 25, and 54 for use as office space by the Tribal Social Service Department and a copy of the property use agreements is attached hereto.

THEREFORE, BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby requests from the Bureau of Indian Affairs that the referenced buildings and property be temporarily transferred to the White Mountain Apache Tribe for its use in carrying out the responsibilities of the Tribal Social Services Program in the best interest of the White Mountain Apache Tribe.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman to execute the property use agreements for the temporary transfer of government quarters Nos. 24, 25, and 54 to the White Mountain Apache Tribe for use in the Tribal Social Service Program.

The foregoing resolution was on September 15, 1988, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


