WHEREAS, Lillian Thompson and her daughter Alva have requested the assistance of the Tribal Council of the White Mountain Apache Tribe with repairs, renovation and possible addition to Mrs. Thompson's mutual help house because of the return home of her handicapped brother; and

WHEREAS, Mrs. Thompson has fully paid off the outstanding mortgage on her home and therefore is eligible and willing to pay for the requested repairs, renovation and possible addition to her house in monthly payments over time to repay the Housing Authority for the initial expense; and


WHEREAS, the Tribal Council of the White Mountain Apache Tribe wishes to assist Mrs. Thompson.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby strongly recommends that the Housing Authority repair, renovate and possibly add to Lillian Thompson's mutual help house and to take appropriate action in this regard related to the needs of Mrs. Thompson's handicapped brother.

WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council has been advised that on January 4, 1989 the Commissioned Corps of the United States Public Health Service celebrates the end of its first hundred years of service and begins its second century of endeavor with the goal of further enhancing the health of citizens; and

WHEREAS, the Commissioned Corps has served on the Fort Apache Indian Reservation since 1955 in concerted efforts of disease control, health promotion, health care delivery, disease prevention, environmental intervention, health program management, and policy development and implementation, as well as innovation in health care for the White Mountain Apache Tribe; and

WHEREAS, the Commissioned Corps has worked with the Apache people to enhance the health of mothers and children, and to provide emergency care services and health care services for the White Mountain Apache people; and

WHEREAS, the Commissioned Corps is committed to continued health care delivery and programs to control disease and to help the White Mountain Apache people achieve optimum health status.

NOW, THEREFORE, BE IT RESOLVED that the Commissioned Corps and the men and women who have served, as well as those who now serve in this select health component, be congratulated for an exceptional effort and multiple individual as well as group accomplishments for the good of the public health, and that the Commissioned Corps be extended best wishes for its continued strength, revitalization and endeavor, for the future success of its efforts, and that Wednesday, January 4, 1989 is PHS Commissioned Corps Day on the Fort Apache Indian Reservation.
