RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the problem of elderly abuse, neglect and exploitation are a nationwide problem; and
- WHEREAS, these problems are in strong evidence on the White Mountain Apache Reservation; and
- WHEREAS, the White Mountain Apache Tribe is dedicated to the identification and abolition of abuse, neglect and exploitation of its elderly constituents; and
- WHEREAS, the Elderly Services Program is the program primarily entrusted with the welfare and care of the elderly;
- WHEREAS, the Elderly Services Program has the knowledge and staff resources to have an impact on the problems of abuse, neglect and exploitation of the elderly; and
- BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe authorizes the White Mountain Tribe Elderly Services Program to submit a proposal to the United States Department of Health and Human Services, Fiscal Year 1989 Coordinated Discretionary Funds Program, under Section 1.4, Training and Technical Assistance for a Family Violence Prevention and Services Program.

The foregoing resolution was on November 10, 1988, duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1(a),(i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
