FORT APACHE INDIAN RESERVATION


WHEREAS, Raymus Albert, Director of the Land Office has come before the Tribal Council and has reviewed the minutes of the Land Board meetings for January 24, 1989, February 10, 1989, March 17, 1989, March 31, 1989, April 7, 1989, April 14, 1989, and May 12, 1989, and the Tribal Council is of the opinion that the Land Board minutes are complete in all necessary respects and should therefore be approved, including all valid actions taken by the Land Board at these meetings; and

THEREFORE BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes including all valid actions taken in those minutes in assigning land to eligible tribal members during the months of January, February, march, April and May 1989.

The foregoing resolution was on May 24, 1989, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

February 10, 1989

A Land Board Meeting was held on February 10, 1989 in the Council Chambers. Members present were Slim Quay, Lula A. Ivins, Esther T. Lupe and Edward Walker. Sidney Baha was absent. The meeting was opened at 9:00 a.m.

Canyon Quintero requested an area by May Altaha's resident in Canyon Day. He was told that this area was reserved for a roadway. This will be checked out first.

Mary Ruth Bush and Gertie Lüpe came regarding Mary Ruth's homesite in North Fork. Gertie told the Board that the Council has referred this case back to the Board. This is a land dispute between Mary Ruth and Barbara J. Harvey. The Board decided to have a special meeting for this case and they will be notified later on.

Betty Harvey asked about a lot in the BIA compound, she was told that it was already approved by the Council.

Luther Ethelbah said he is having problems with his neighbor Buddy Gloschay and wants to have it stopped. He was told that a survey will be done and a letter written to Mr. Gloschay.

Omar Aday and Casey Moody's land dispute was discussed. They both wanted a farm and assignment in the same area in Chino Springs. Casey said his witnesses didn't show up so he was told to come back with them next Friday, April 7th. Omar & his daughters said the land belongs to them and should be theirs. They were told that they didn't have to come to the next meeting.
