RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the tribal Fair & Rodeo Commission does not have enough funds to finance the the Tribal Fair and Rodeo for 1989; and

WHEREAS, the Tribal Council concludes that said budget should be approved for the Fair and Rodeo of an operating budget of \$45,000.00 for the 1989 Tribal Fair and Rodeo.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Tribal Fair and Rodeo budget for Fiscal Year 1989-90

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the proposed Fair and Rodeo budget for Fiscal year 1989-90 in the amount of \$45,000.00 based on the projected revenues of \$45,000.00 to be repaid to the White Mountain Apache Tribe ten (10) days following the end of the Fair and Rodeo for 1989 as presented and the same is hereby adopted and placed into full force and effect as of June 15, 1989.

The foregoing resolution was on June 19, 1989, duly adopted by a vote of 6 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the amended constitution and bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48) Stat. 984).

WHEREAS, THE TRIBAL FAIR & RODEO COMMISSION DOES NOT HAVE ENOUGH FUNDS TO FINANCE THE TRIBAL FAIR & RODEO FOR 1989; AND

WHEREAS, THE TRIBAL COUNCIL CONCLUDES THAT SAID BUDGET SHOULD BE APPROVED FOR THE FAIR & RODEO OF AN OPERATING BUDGET OF \$45,000.00 FOR THE 1989 TRIBAL FAIR & RODEO.

BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE WHITE MOUNTAIN APACHE TRIBE THAT IT HEREBY APPROVES THE TRIBAL FAIR & RODEO BUDGET FOR FISCAL YEAR 1989-90.

THEREFORE BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE WHITE MOUNTAIN APACHE TRIBE THAT IT HEREBY APPROVES THE PROPOSED FAIR & RODEO BUDGET FOR FISCAL YEAR 1989-90 IN THE AMOUNT OF \$45,000.00 BASED ON THE PROJECTED REVENUES OF \$45,000.00 TO BE REPAID TO THE WHITE MOUNTAIN APACHE TRIBE TEN (10) DAYS FOLLOWING THE END OF THE FAIR AND RODEO FOR 1989 AS PRESENTED AND THE SAME IS HEREBY ADOPTED AND PLACED INTO FULL FORCE AND EFFECT AS OF JUNE 15, 1989.

THE FOREGOING RESOLUTION WAS ON JUNE ^{20 njc} 15, 1989, DULY ADOPTED BY A VOTE OF 6 FOR AND 0 AGAINST BY THE TRIBAL COUNCIL OF THE WHITE MOUNTAIN APACHE TRIBE, PURSUANT TO AUTHORITY VESTED IN IT BY ARTICLE V, SECTION 1 (1) OF THE AMENDED CONSTITUTION AND BYLAWS OF THE TRIBE, RATIFIED BY THE TRIBE JUNE 27, 1958, AND APPROVED BY THE SECRETARY OF THE INTERIOR ON MAY 29, 1958, PURSUANT TO SECTION 16 OF THE ACT OF JUNE 18, 1934 (48 STAT. 984).
