

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, by previous Tribal Council consension District II Councilmen Kino Kane and Lafe Altaha were directed to make a determination as to future plans for the old employees house located next to the Old Cedar Creek Trading Post in Cedar Creek; and

WHEREAS, the District II Councilmen, after considering suggestions and requests concerning the disposition of the old employees house in Cedar Creek, recommend that the above mentioned house and land upon which it is situated be given as a gift to Roger Clawson, Sr., an enrolled member of the White Mountain Apache Tribe;

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby concurs with the recommendation of District II Councilmen to turn over ownership of the old Cedar Creek Trading Post employees house to Roger Clawson, Sr.;


BE IT FURTHER RESOLVED that the Chairman of the White Mountain Apache Tribe, and in his absence the Vice-Chairman, is hereby authorized to execute all necessary documents to effectuate this transfer;

BE IT FURTHER RESOLVED that the Director of the Tribal Land Office is hereby directed to execute any and all documents necessary to give a homesite on the land upon which the house is situated to Roger Clawson, Sr.

The foregoing resolution was on September 19, 1989, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) and (m) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

DECLARATION OF GIFT

The White Mountain Apache Tribe of the Fort Apache Indian Reservation, is the owner of the property described below, and desires to give as a gift the described property to ROGER CLAWSON, SR., an enrolled member of the White Mountain Apache Tribe.


To carry out this purpose, the White Mountain Apache Tribe does hereby give and deliver to ROGER CLAWSON, SR., the property described as follows:

1. The 4-room wood frame house, known as the old employees house, which is located in Cedar Creek, Arizona next to the Old Cedar Creek Trading Post; and
2. The land upon which the old employees house is situated shall be designated a homesite in the name of Roger Clawson, Sr. The land upon which the house and the Trading Post are located shall be divided equally at a point equidistant between the old Cedar Creek Trading Post and the above described house.

It is distinctly understood between the parties that it is the purpose and intent of the White Mountain Apache Tribe to vest all the incidents of absolute ownership of the above described house in ROGER CLAWSON, SR.

Further, the above described property is given to ROGER CLAWSON, SR. "as is" and the White Mountain Apache Tribe is not responsible for costs or expenses incurred in the renovation of said property.
