


RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Raymus Albert, Director of the Land Office has come before the Tribal Council and has reviewed the minutes of the Land Board meetings of August 4, 14, 1989 and September 15, 1989, and the Tribal Council is of the opinion that the Land Board minutes are complete in all necessary respects and should therefore be approved, including all valid actions taken by the Land Board at these meetings.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes and ratifies all valid actions taken and reflected in those minutes in assigning land to eligible tribal members during the months of August and September 1989.


The foregoing resolution was on November 2, 1989, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (h) (m) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

August 14, 1989
