

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION


- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is advised by the Housing Improvement Program (H.I.P.) Coordinator, Ms. Beverly A. Stago, that it is imperative that the Tribal Council authorize the selection of persons for the 1990 H.I.P. homes and the construction of said homes in compliance with the H.I.P. Housing Improvement Program Grant; and
- WHEREAS, it is recommended to the Tribal Council that authorization be granted for construction of five new homes for the FY-1990 Housing Improvement Program Contract; and
- WHEREAS, there is a need to eliminate one home from District IV to meet the cost of constructing a specially equipped home for an individual who was selected from District II, a handicapped - paraplegic individual; and
- WHEREAS, the Phoenix Area Housing Office is working on an alternate cost estimate to construct the specially equipped house to meet the requirements and need of this individual; and
- WHEREAS, a third individual will be named as an alternate for District IV, should funds be available for an additional home to be constructed in District IV; and
- WHEREAS, the H.I.P. Selection Committee has made their final selection for FY-1990; and
- WHEREAS, the final selections are as follows:

District IV - Jacqueline Josay
Martha Moyah
Alternate - Freddie Massey

The foregoing resolution was on January 10, 1990, duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
